



Performance and Market Review

The portfolio was up 3.96% in Aug 2023, outperforming the S&P BSE 500 TRI Index benchmark by 458 bps. The allocation to mid cap & small cap increased by 0.6% and 1.1% respectively 1.73% while for large cap reduced by 1.70% as compared to 31st July 2023. The allocation to Financial Services & FMCG increased by 70 bps and 48 bps respectively as compared to 31st July 2023, while allocation to Healthcare decreased by 101 bps.

In Aug 2023, S&P BSE 500 TRI index was down 0.61% on the month-on-month basis. The large cap was down 2.41% while mid cap and small cap indices were up by 3.92%, and 5.07% respectively in Aug 2023.

Sector-wise IT index was up 4.13% on m-o-m basis. During the same period Energy, Financial Services and FMCG indices were down by 4.21, 3.66% & 2.93% respectively.
