



Performance and Market Review

The portfolio was up 0.52% in Sep 2023, underperforming the S&P BSE 500 TRI Index benchmark by 159 bps. The allocation to small cap increased by 6.3% while for mid cap reduced by 7.8% as compared to 31st August 2023. The allocation to Financial Services increased by 434 bps as compared to 31st Aug 2023, while allocation to FMCG decreased by 872 bps.

In Sep 2023, S&P BSE 500 TRI index was up 2.11% on the month-on-month basis. The large cap was up 1.94% while mid cap and small cap indices were up by 3.04%, and 2.51% respectively in Sep 2023.

Sector-wise, PSU Bank Index was up 17.7% on m-o-m basis. During the same period, Energy, Auto and Metal indices were up by 6.22%, 3.28% & 2.70% respectively.
