





Performance and Market Review

The portfolio was up 6.27% in July 2024, outperforming the S&P BSE 500 TRI Index benchmark by 1.82%. The allocation to mid-cap & small-cap decreased by 05 & 87 bps respectively as compared to 30th June 2024, while allocation to large-cap increased by 92 bps. The allocation to Financial Services & Healthcare increased by 287 bps & 107 bps respectively as compared to 30th June 2024, while allocation to FMCG decreased by 556 bps.

In July 2024, S&P BSE 500 TRI index was up by 4.44% on the month-on-month basis. The large cap, mid-cap & small cap were up 4.07%, 4.94% & 4.89% respectively in July 2024.

Sector-wise, IT, FMCG & Healthcare were up by 12.98%, 9.38% & 9.34% respectively. During the same period, Metals were down 2.35%.
