



Performance and Market Review

The portfolio was up 0.2% in Oct 2024, outperforming the S&P BSE 500 TRI Index benchmark by 6.6%. The allocation to large-cap & mid-cap decreased by 88 & 30 bps respectively as compared to 30th Sep 2024, while allocation to small-cap increased by 117 bps. The allocation to FMCG & Auto increased by 237 bps & 157 bps respectively as compared to 30th Sep 2024, while allocation to Financial Services decreased by 186 bps.

In Oct 2024, S&P BSE 500 TRI index was down by 6.5% on the month-on-month basis. The large cap, mid-cap & small cap were down 6.8%, 6.4% & 3.6% respectively in Oct 2024.

Sector-wise, Auto, Energy & FMCG were down by 13.0%, 10.7% & 9.7% respectively. During the same period, PSU Banks were down only 0.5%.
