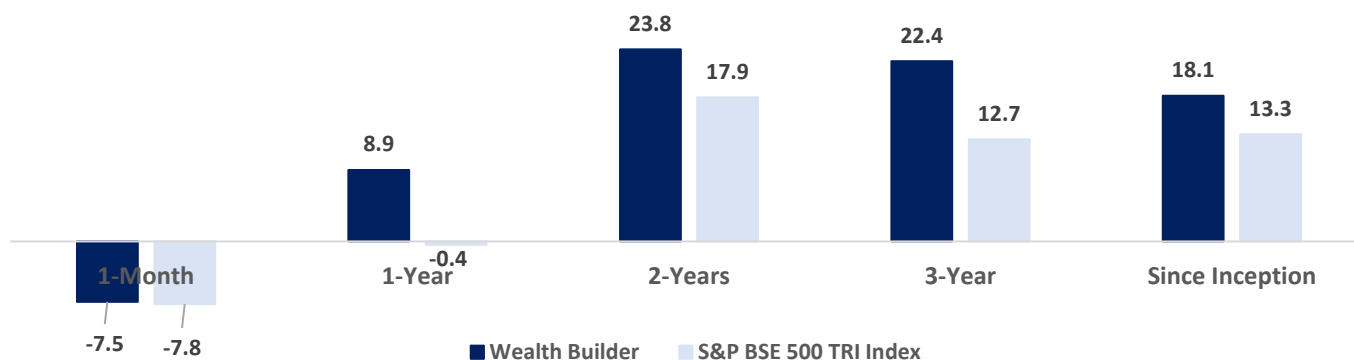


# FACTSHEET – Wealth Builder

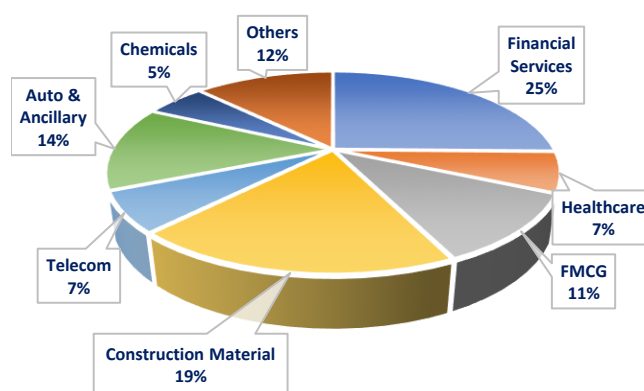

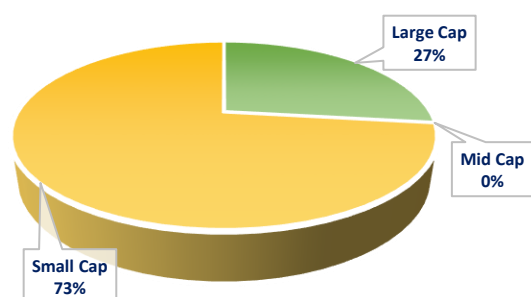

## Performance and Market Review

The portfolio was down 7.48% in Feb 2025, outperforming the S&P BSE 500 TRI Index benchmark by 0.26%. The allocation to large-cap increased by 243 bps as compared to 31<sup>st</sup> Jan 2025, while allocation to small-cap decreased by 243 bps. The allocation to Construction material & Telecom increased by 287 bps & 101 bps respectively as compared to 31<sup>st</sup> Jan 2025, while allocation to Financial Services decreased by 305 bps.

In Feb 2025, S&P BSE 500 TRI index was down 7.74% on the month-on-month basis. The large cap, mid cap & small cap were down 6.54%, 10.58% & 12.66% respectively in Feb 2025.

Sector-wise, IT, Energy, FMCG, PSU Banks and Auto were down by 12.5%, 11.4%, 10.6%, 10.5% & 10.4% respectively.
